<b>HEALTH INSURANCE</b>	<p>All full-time international students are required to subscribe to NUS Full-time Student Insurance Scheme when admitted to NUS. The health insurance fee will be included in the Miscellaneous Student Fees of the student bill on a semester basis. <b>This is a compulsory scheme. Opt-out is not allowed.</b></p>
<b>VISA INFORMATION</b>	<p>All international students must hold a valid Student's Pass issued by the Singapore Immigration and Checkpoints Authority for their studies at NUS. Once an international applicant indicates acceptance of the offer, NUS will submit an application for the Student's Pass on behalf of the applicant. Each new application must be submitted at least one month and not more than two months before the commencement of the course.
